Assumption of Risk:

Release and Waiver of Liability, Assumption of Risk, and Indemnity and Parental Consent Agreement

In consideration of being permitted to participate in any way in the MVP Sports Center or Sports Factory I for myself or personal representatives, assigns, heirs, and next of kin:

1) Acknowledge, agree, and represent that I understand the nature of the activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe condition to be unsafe, I will immediately discontinue further participation in the activity.

2) Further understand: (a) activities involve risks and dangers of serious bodily injury, including permanent disability paralysis and death (Risks); (b) these risks and dangers may be caused by my own actions or inaction's the actions or inaction's of others participating in the activity, the condition in which the activity takes place, or the negligence of the "releases" named below: (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time' and I fully accept and assume a'' such risks and all the responsibility for losses and costs and damages I incur as a result of my participation or that of a minor in the activity.

3) Hereby release, discharge and covenant not to sue their respective administrators, directors, agents, officers, members, volunteers and employees, other participants, any sponsors, advertisers, and if applicable, owner and lessors of premises on which the activity takes place, each considered one of the "releases" herein FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this release and waiver of my liability, assumption of risk, and indemnity agreement I or anyone on my behalf, makes a claim against any of the releases, I will indemnify, save and hold harmless each of the Releases from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
